DC/18/3782/TCA: Dennington VC Primary School, Laxfield Rd, East boundary of school - to coppice all shrubs within 3m of chain link fence: Councillors agreed unanimously to support the application
DC/18/3784/TCA: Churchyard, Dennington Street - T1 semi mature lime next to pub decked area - reduce height by 4.5 m, reduce width by 2.5m, remove dead wood and epicormic growth:
T2 lime near front of pub - reduce height by 4.5 m, reduce width by 2.5m, remove dead wood and epicormic growth:
